NCDC Implementation of Central Sector Scheme for Formation and Promotion of 10,000 FPOs by KVKs

Implementing Agency

Department of Agriculture, Co-operation & Farmers Welfare, Ministry of Agriculture & Farmers Welfare, Government of India has introduced the CSS Formation and Promotion of 10,000 FPOs under Co-operative Societies Act. Formation of FPOs is targeted in five years period of 2019-20 till 2023-24 while handholding will continue till 2027-28. DAC & FW act as a funding source and NCDC along with ICAR is the implementing agency.

At ICAR-ATARI, Pune it is being implemented in total 10 blocks in 6 KVKs, out of which there are 6 blocks (Karad, Satara, Malshiras, Pandharpur, Shirol, Hatkangale) from 4 KVKs (Satara-I, Satara-II, Kolhapur-I, Solapur-II) from Maharashtra and 4 blocks (Deesa, Dantiwada, Nandod and Dediapada) from 2 KVKs (Banaskanta-I and Narmada) of Gujarat with the aim to enhance economic strength & market linkages of farmers for enhancing their income.

A District Level Monitoring Committee (D-MC) is constituted in which, District Collector as Chairperson and CEO District Council as Member closely monitor and review the progress of FPO development and functioning along with financial matters by holding its regular meetings. It identify the constraints in implementation of scheme at the ground level and communicate the same to State Level Consultative Committee for further taking up the matter with DAC & FW and N-PMAFSC for appropriate policy decisions.

Objective

The Objective is to provide adequate handholding and professional support to develop economically sustainable FPOs while facilitating adequate market and credit linkages.

Funding

10 blocks have to registered one FPO each, till date total 9 FPOs have been registered with 3158 number of registered farmer members. Rs. 20 Lakhs has been distributed to 10 blocks (Rs. 2 lakh per block) in October 2021 and Rs. 13.31 Lakhs disbursed to 4 blocks of 2 KVKs (Rs. 8.35 lakh to Banaskantha-I and Rs. 4.96 Lakh to Kolhapur-I KVK) in September 2023 for expenditure against Cost of CBBO.
